TERMS OF SUMMERHOUSE RENTAL

1. Agreement on the summerhouse rental is concluded at the time at which the customer signs the present conditions of participation or on the website has marked a window of summerhouse terms acceptance and paid an advance of 20% of the value of the renting. The remainder of the amount should be paid 30 days before the beginning of the stay in the house. If the reservation was made in less than 30 days until the start of the stay, the customer pays 100% of the amount.

2. If the customer fails to comply with the timely payment of claims will be removed from the list of reservations.
3. Rent of houses is preferred in the weekly intervals (from Saturday to Saturday).
4. Stay in the house starts on the first day from 4 pm and will end at 11 am the last day of stay. The keys are handed on the spot in a rented house.
5. Customer receives a route description and contact to the owner of the selected house after the transfer of fullpayment
6. The house can be used by the number of people, which is defined in the price list.
7. Presence in the cottage more people than the category of the house indicates, must be preceded by the agreement of the owner and an additional fee of 25zł / person / day. Staying more people without the above arrangements will result in eviction of all customers without a refund for the unused period of rest.
8. Bringing pets is possible only after agreement with the "Grand-Tourist".
9. Customers are welcomed to the houses only on the basis of vouchers issued by "Grand-Tourist"
10. The cost of the withdrawal of the stay in the summerhouses:
 - up to 33 days no more than 30 zł
 - between 32 and 16 day no more than 25% of the cost of your stay
 - between 15 and 8 day no more than 50% of the cost of your stay
 - less than 7 days no more than 90% of the cost of the stay.
11. Customer complaints should be reported by telephone to the Grand -Tourist or to the owner of the house during the stay to allow the organizer to remove inconveniences or exchange house. Complaints made at a later date will not be considered.
12. On the start of stay guests pay back a deposit of 300 PLN to cover any minor damage. The customer is responsible financially for any damage caused to the house.
13. The price includes: Accommodation (7 nights) with the possibility to use all the equipment mentioned in the description of the house, bed linen and garden.
14. Additional costs: a) electricity by meter indication, b) fuel to fire place and grill, the above claims are paid directly to the owner of the house on the end of the stay.
15. On the departure day the house should be after general cleaning (empty trash bin, washed dishes, removed sheets, swept floor)- if not the owner has a right to charge 50 PLN for last cleaning.
